### AGM AND BOARD MEETING NOVEMBER 2012 AND BOARD **MEMBERS' RETIREMENT DATES**

#### 1. **SUMMARY**

This report proposes a date for the November AGM and Board meeting and asks the Board to extend the retirement dates of Board and City Board Members who are due to retire in October to November.

#### 2. RECOMMENDATION

- 2. to amend the retirement dates of Board Members and City Board Members from October to November, as set out in Appendix 1.

#### 3. MATTER FOR CONSIDERATION

- 3.1 The programme of Board and Committee meetings for the year, from November until October, is agreed at the First Meeting of the Board following the AGM. At its last meeting, the Board agreed to change the format of the AGM and to hold it in November before the Board meeting. The Board will therefore need to set and agree a date for the November AGM and Board meeting.
- 3.2 It is proposed that the AGM and Board meeting are held on Thursday 29 November at 5.00 pm. The AGM will be followed by a Board meeting, the agenda for which will be in accordance with Standing Order 1 and any other business which cannot wait until the next meeting in January.
- 3.3 Currently Board Members and City Board Members' retirement dates are set for the AGM in October. The Board is asked to extend retirement dates until the November AGM. The rota for the retirement of Board Members is attached at Appendix 1.
- 3.4 If approved by the Board, the Council's approval will need to be sought to amend the Independent Board Members' retirement dates as they are appointed by the Council. All future retirement dates would also be realigned with the AGM being held in November each year.
