PROCUREMENT WAIVERS

Report of the Director & Company Secretary

1. SUMMARY

To present the Committee with information relating to the requests to waive Derby Homes' Procurement Standing Orders.

2. RECOMMENDATION

To note the report.

3. MATTER FOR CONSIDERATION

- 3.1 A previous report was presented to the Resources, Remuneration and Regeneration Committee updating the Committee on the requests and outcomes of procurement waivers prior to 7 July 2011.
- 3.2 This report is presented to the Committee to give an update on procurement waiver requests and outcomes post 7 July 2011. It gives the current position with regards to Procurement Standing Order waivers.
- 3.3 The current waiver register has a total of 24 requests to waive the Derby Homes' Procurement Standing Orders. Of those granted, 23 are still live.

3.4 Waivers expiring in 2012

- D W Haines granted until December 2012 to ensure difficult access to properties needing gas servicing is completed, as required by law.
- Just Housing Consultancy granted until December 2012 to help with the integration of the repairs team into Derby Homes. This work is now complete.
- SWALEC / ESPO electricity supplies granted until October 2012 to ensure economies of scale are achieved through a bulk purchase agreement with Derby City Council.
- Derby Loans (IPS) Ltd granted until August 2012 to make affordable finance available to Derby Homes' communities.
- Wescot Credit Services granted until November 2011 to ensure collection of rent arrears is not disrupted until the Income Management Team have undergone a re-structure and a re-procurement timetable is agreed.
- Renew Maintenance Social Enterprise involving young unemployed trainees, granted until November 2012.
- Kleensafe Social Enterprise involving young unemployed trainees, granted

- until November 2012.
- Callcredit Information Group granted for three months until June 2012 to validate the occupancy of existing tenancies this work is now complete and the waiver will not need to be renewed.
- Dial-a-Rod granted until September 2012 to allow time to undertake a procurement exercise. This is underway and should be completed by the time this waiver expires.

3.5 Waivers expiring in 2013

- Vinshire Plumbing & Heating granted until March 2013 to cover the Out-Of-Hours gas repairs.
- Contractors, Sub-Contractors and Suppliers granted until May 2013 in order to regularise the arrangements inherited by Derby Homes from the merger in June 2010 with the Repairs Team and in order to cover all of the re-procurement exercises necessary. Temporary contracts have been issued and re-procurement timescales set.
- Hobsons Health granted until July 2013 to allow the provision for an Occupational Health Service with Rykneld Homes to continue.
- SDLC Solutions granted until March 2013 to allow the delivery and support of the "Open Contractor" project.
- Allan Webb granted until March 2013 to allow support for the scanning of documents for the Personnel, Maintenance and Finance departments.
- Kainos Software granted until May 2013 to ensure the Meridio system is fully supported, it being a critical business system.

3.6 Waivers expiring in 2014

- Neopost granted until March 2014 to support the hybrid mail system, preventing any possible disruption to the mail system.
- Marlin's Design granted until April 2014 for Architect services on the new build scheme.
- Netmotion Wireless Ltd granted until April 2014 to secure the data route of laptops accessing Derby Homes information.

3.7 Waivers expiring in 2015

- Equality Works granted until March 2015 to continue with the rolling programme of Equality and Diversity training.
- Bytes Software Services granted until May 2015 to allow the purchase of licenses to use Microsoft software.
- Meridio granted until May 2015 to allow the implementation of Derby City Council's preferred document management system.

3.8 Waivers expiring in 2016

 Housemark – granted until May 2016 to allow Derby Homes to benchmark Key Performance Indicators against other housing sector organisations.

Waivers expiring in 2017 3.9

- First Care granted until May 2017 to provide Derby Homes with an electronic self-certification provision and management information relating to absence / attendance within the organisation.
- Octavia Software Solutions granted until May 2017 to provide software for Supported Living Services to replace the previous paper-based system which was regarded as high-risk.

4. LEGAL AND CONFIDENTIALITY IMPLICATIONS

- 4.1 Legal advice was obtained in relation to the service delivery required following the Connaught Partnership collapse and in relation to continued delivery of the Repairs Team's service. The waivers granted for specialist work were of a significantly low value not to present a legal issue.
- 4.2 The legal advice relating to the Connaught Partnership issue was that if Derby Homes did not grant waivers it would leave the organisation at significantly greater risk. The significant risk would be caused because Derby Homes would have no resources available to comply with its obligation under the Health and Safety at Work Act. The specific risk would be non-compliance with the Gas Safety (Installation and Use) Regulations which is part of the Health and Safety at Work Act.
- 4.3 In relation to the service delivered by the Repairs Team, the advice received was to regularise the arrangements with the sub contractors until a move to compliant procurement arrangements can be achieved.

5. **HEALTH & SAFETY IMPLICATIONS**

- 5.1 Not to grant waivers for gas safety inspection and servicing work could have resulted in significant health and safety risks. It would also have resulted in Derby Homes breaching the Health and Safety at Work Act.
- 5.2 All other live waivers do not have a health and safety implication but a number do have business continuity implication.

RISK IMPLICATIONS 6.

- 6.1 Waivers granted for gas safety and other repairs sub contracted work have a risk to the business as the value exceeds the European procurement thresholds. Legal advice suggests that any challenge is unlikely to succeed due to the nature of the health and safety implications and the structured way in which Derby Homes is moving to place such contracts on a fully competitive basis.
- 6.2 All other procurement waivers are of a significantly low value not to present a risk.
