### **CALENDAR OF PROPOSED ATTENDANCE AT EVENTS 2009/10**

#### 1. SUMMARY OF REPORT

This report summarises Derby Homes' commitment to attending public events in 2009/10 and states the intended aims and outcomes of these commitments. The calendar for the events is found in Appendix 1 attached.

- 3.1 Attendance at the events listed in this report will be used to:

  - engage with hard to reach groups as part of our commitment to Equalities
  - promote involvement itself
- 3.2 Our attendance at these events will be using the Housing Focus Group Lite format. Our aim will be to bring back useful information from the communities we work with that will help to develop future service delivery.

#### 4. CONSULTATION IMPLICATIONS

The events will be used to consult tenants/residents. The Tenant Involvement Team will work with service managers to develop areas for consultation for use at these events.

#### 5. FINANCIAL AND BUSINESS PLAN IMPLICATIONS

Attendance at weekend events is covered by a combination of overtime payment and time off in lieu, dependant on the pay scale of the employees attending. All costs are contained within existing salary budgets.

#### 6. LEGAL AND CONFIDENTIALITY IMPLICATIONS

Derby Homes is required to regularly consult and involve service users in the management and development of its services under the 1985 Housing Act, Section 105.

#### 7. PERSONNEL IMPLICATIONS

Attendance at weekend events is achieved by voluntary attendance by staff, employment contracts for the Tenant Involvement Team cover occasional Saturday working.

#### 8. ENVIRONMENTAL IMPLICATIONS

We will use the Community Watch Patrol Van to transport equipment to events to negate the use of multiple personal vehicles being used to attend the event.
