- 4.2 The Appointments Panel interviewed 3 candidates on 23 and 24 September for two Tenant Board Member positions.

The Board agreed to extend his term of office beyond the MTO, subject to interview by the Appointments Panel, at the meeting in March this year (Minute 19/47).
