APPOINTMENT OF BOARD MEMBERS

1. SUMMARY

This report advises of appointments made to the Board of Derby Homes.

2. RECOMMENDATION

That the Board notes the appointments and terms of office for Tenant and Independent Board Members:

- Fiona Walker, Tenant Board Member for the period 27 November 2014 until the AGM 2016
- 2. Bob MacDonald, Tenant Board Member for the period 27 November 2014 until the AGM 2017
- 3. Jsan Shepherd, Independent Board Member for the period 27 November 2014 until the AGM 2017.

3. MATTER FOR CONSIDERATION

- 3.1 At its meeting in July, the Board agreed the commencement of processes to recruit an Independent and two Tenant Board Members. The Board delegated authority to the Appointments Panel to make decisions on the selection criteria and the appointments to ensure the Board Members could take up their position at the AGM.
- 3.2 Ten applications were received for the Independent Board Member position. The Independent Board Member Appointments Panel, comprising Mike Ainsley, Dennis Rees, Maria Murphy and David Enticott, interviewed five candidates on the 17 October and a further one on the 3 November.
- 3.3 The Panel has recommended the appointment of Jsan Shepherd to the Council, in accordance with Article 16(6), at its meeting on 26 November and the outcome will be reported verbally at the meeting.
- 3.4 Two applications were received for the two Tenant Board Member positions. One from Fiona Walker, current Tenant Board Member, and one from Bob MacDonald, an Operational Board Member.
- 3.5 The Tenant Board Member Appointments Panel comprising Mike Ainsley, Dennis Rees and Taran Lalria, agreed to reappoint Fiona Walker and following interview on the 24 October, appointed Bob MacDonald.
