He highlighted some of Derby Homes' achievements over the past year, including estate improvements and new homes, the apprenticeship scheme and improvements in the repairs service.

He thanked all Board Members standing down this year and those who had stood during the years. He congratulated Councillor Baggy Shanker on his appointment to the Board, adding that he will be a valuable addition to Derby Homes Board.

The Leader referred to Derby Homes' achievements in the past year and said he looked forward to working with the organisation in the coming year. In particular he congratulated Derby Homes on its apprenticeship scheme, working with other housing providers, such as the War Memorial Village, its partnership working with OSCAR and the Council itself, especially regarding the building of new homes.

He concluded by saying he was confident that together, Derby Homes and the Council will provide quality housing in the City. He wished Derby Homes' success in the year ahead and was proud to receive its Annual Report.

13/11 Any other competent business

There was no other business.

13/12 Questions from the floor

Representatives of the Leaseholders Group asked the Shareholder why he had over-ridden the Board's decision and excluded Leaseholders from eligibility to be considered as one of the Tenant representatives on the Main Board.

The Leader of the Council responded explaining the decision was made on the basis of proportionality; the number of tenants eligible to become Board Members far exceeds the number of leaseholders. He added that he believed Leaseholders can make a valuable contribution to the City Board. He noted that the opportunity for a co-opted Board Member had not been taken up.

In response to a secondary question regarding the Leaseholder Board Member's contribution and commitment, the Leader repeated that the co-opted place on the Board was not taken up but Leaseholders can apply for any Independent vacancies that arise. The decision was made with regard to principles of proportionality and reasonableness towards tenants. He added that Derby Homes' governance arrangements will be reviewed, and there will be an opportunity to review this decision.

The question of whether or not leaseholders are tenants, the Director of Derby Homes replied that the legal definition of a Tenant Board Member is divorced from the definition of secure Tenants and Leaseholders. She added that Derby Homes will value contribution from Leaseholder involvement on the City Board, which will now have greater responsibility delegated to it from the main Board; it will be a forum where services received by tenants and leaseholders will be examined and she hoped that Leaseholders will continue to contribute.
