TENANCY POLICY UPDATE

Report of the Head of Housing Management

1. SUMMARY

1.1 Derby Homes's Tenancy Policy was reviewed by the Operational Board on 10 March 2022 and approved at the Main Board in March 2022. Minor updates are recommended to ensure the policy accurately reflects all regulatory requirements and tenancy options available to Derby Homes.

2. RECOMMENDATION(S)

2.1 To recommend to the main board that the minor amendments to the policy are approved.

3. REASON(S) FOR RECOMMENDATION

3.1 To ensure the Derby Homes Tenancy Policy remains fit for purpose.

4. MATTER(S) FOR CONSIDERATION

- 4.1 Section 3.9 has been added to include Demoted Tenancies. Whilst these are not currently being used by Derby Homes, they are an option available to us and will be considered in the future, where appropriate.
- 4.2 Sections 11.1 and 11.4 of the policy have been updated to include the Civil Partnership (Opposite-sex Couples) Regulations 2019 which amended the Housing Act 1985 succession criteria further to include "a person who, immediately before the previous qualifying occupier's death was living together with the previous occupier as if they were a married couple or civil partners shall be treated as the widow, widower or surviving civil partner of the previous occupier".
