

OPERATIONAL BOARD**9 June 2022****SAFEGUARDING POLICY UPDATE**

Report of the Head of Housing Management

1. SUMMARY

- 1.1 This policy has been updated following a recent audit carried out by Central Midlands Audit Partnership.

2. RECOMMENDATION(S)

- 2.1 To approve the minor amendments to the policy

3. REASON(S) FOR RECOMMENDATION

- 3.1 Acceptance of the audit recommendations to strengthen our Policy and Training documents.

4. MATTER(S) FOR CONSIDERATION

- 4.1 Central Midlands Audit Partnership recently carried out a comprehensive audit on safeguarding practice at Derby Homes. Their concluding report awarded a rating of substantial which is the highest category possible.

- 4.2 The report made two recommendations, both of which were considered to be low risk. The recommendations were that consideration should be given to expanding on the detail contained in the Safeguarding Policy and training slides to explain the circumstances where it would be reasonable for a member of staff to override the sharing of information without consent, such as:

- a crime has been committed or sharing the information could prevent a crime
- the person lacks mental capacity to make the decision
- the person has mental capacity to make the decision but may be under duress, threatened or coerced
- other people are, or may be at risk, including children or young people
- staff are implicated
- the alleged abuser is also an adult at risk
- the information is requested by court order or other legal authority

The safeguarding principle of proportionality should underpin decisions about sharing information without consent
