1. SUMMARY

This report summarises the expenditure on legal and professional services during the financial year ended 31 March 2011 and explains the process for the selection of consultants.

3. MATTER FOR CONSIDERATION

- When a need for professional services is identified, the Executive Team makes the decision to appoint consultants, including the identification of a budget.

However, due to the specialist nature of the services, it is not always possible to obtain quotes from a range of providers. Where the Derby Homes Procurement Procedures are not applied a waiver will be completed.
