#### 3. MATTER FOR CONSIDERATION

#### 3.1 ACCIDENT AND INCIDENT REPORTS

Accidents and incidents involving Derby Homes' staff are recorded using a formal reporting system. In November and December there were eight reported accidents. One of these resulted in a Lost Time Accident (LTA) following a road traffic accident.

- 3.2 More details are shown in the attached accident and incident trends chart (Appendix 1).
- 3.3 For the year January to December 2011 there were a total of 41 recorded accidents. Of these, five resulted in less than three day lost time incidents and one was an over three day lost time and therefore reportable under Reporting of Injuries, Diseases and Dangerous Occurrences' Regulations (RIDDOR).

#### **VIOLENCE AND AGGRESSION REPORTS**

- 3.4 Violent, aggressive or abusive incidents towards staff are reported by staff using a formal reporting system. Appropriate action is always taken against the perpetrator. In November and December there were seven reported cases of violence, aggression or abuse towards staff. More details are shown in the attached violence and aggression trends chart. Details of these incidents and other occurrences are also shown (Appendix 1).
- 3.5 For the year January to December 2011 there were a total of 39 recorded incidents.

#### 4. HEALTH & SAFETY IMPLICATIONS

It is a legal responsibility of the Board to ensure effective health and safety management is maintained within the company. This report provides the relevant information to enable the Board Members to monitor this.





# NOTE: The details of incidents and actions in this summary are reproduced as they appeared in the original reports and intended as a guide only. Some details may have been omitted or paraphrased for the purpose of this summary.

WARNING INDICATORS: When a warning indicator is placed on the housing management system it will be subject to review. All warnings will stay on for a minimum of six months and are then reviewed twice per year.

08/11/2011	Abusive and racist language used during a telephone call with a temporary accommodation officer.	Warning put on Academy for no lone visits. Warning letter sent to occupant.
25/11/11	Verbal abuse and intimidating behaviour.	Warning put on Academy for staff not to visit alone. Warning letter sent to tenant.
25/11/11	Tenant advised Housing Officer that he had verbally threatened neighbours' grandson following noise nuisance over night.	Police Advised. Joint visit with Housing Officer and Police to warn tenant. Warning put on Academy for no lone visits.
30/11/11	Verbal abuse and intimidating behaviour during an interview with a Housing Assistant.	Warning put on Academy for staff not to visit alone. Warning letter sent to tenant about behaviour and banned from office.
06/12/11	Verbal abuse to officer and contractor on site from disgruntled tenant.	Situation to be monitored as no previous incidents.
06/12/11	Verbal abuse and intimidating behaviour directed at repairs operative.	Warning put on Academy for staff not to visit alone. Warning letter sent to tenant.
08/12/11	Tenant was verbally abusive and threatening to Neighbourhood Safety Officer at staff entrance to Housing Office. Tenancy has been extended and tenant has apologised for the incident.	Warning put on Academy for staff not to visit alone. Warning letter sent to tenant.
14/12/11	Verbal abuse and offensive language during a phone call with a Housing Officer.	Warning put on Academy. Warning letter sent to tenant.
21/12/11	Tenant used offensive language in a loud and aggressive manner. Further information then received from social worker not to visit alone.	Warning put on Academy for staff not to visit alone. Warning letter sent to tenant.
