# DRAFT DERBY HOMES' CHILDREN AND YOUNG PEOPLES STRATEGY

Report of the Chief Executive

#### 1. SUMMARY OF REPORT

This strategy has been prepared by a group of Derby Homes' staff who deal with children and young people as part of their work. It aims to ensure Derby Homes helps deliver the Derby City Partnership Children and Young People (C&YP) Plan, and representatives from the C&YP services joined the group.
