

# CHANGE TO STANDING ORDERS

Report of the Finance Director & Company Secretary

#### 1. SUMMARY

1.1 At the Extraordinary Board meeting (EBM) on 27<sup>th</sup> October, the Board referred back to this Committee the wording of a possible change to Standing Orders to consider and recommend wording to the Board.

## 2. **RECOMMENDATION**

2.1 That the Governance Committee recommends the change to Standing Order 1 set out in section 4.3 below.

# 3. REASON(S) FOR RECOMMENDATION

3.1 To ensure that there is always a casting vote for the election of Chair.

# 4. MATTER FOR CONSIDERATION

- 4.1 At the extraordinary Board meeting, a couple of suggested improvements to the proposed revision to Standing Orders were suggested.
- 4.2 Currently Standing Order 1 relates to the first board meeting following the AGM:

1. FIRST MEETING

At the first meeting following each Annual General Meeting of Derby Homes, the Board shall

- (a) elect a person to preside if the Chair is not present
- (b) receive apologies
- (c) consider late items to be added to the agenda by the Chair
- (d) receive any declarations of interest from Board Members
- (e) elect or reaffirm the Chair for the ensuing year
- (f) elect the Vice Chairs for the ensuing year

- (g) approve the minutes of the last meeting
- (h) receive any announcements from the Chair
- (i) decide which committees, to establish for the next year
- (j) decide the size and terms of reference for those committees

(k) appoint to those committees, and outside bodies except where appointment to those bodies has been delegated to the Managing Director

(I) agree a scheme of delegation or such part of it as it sees fit

(m) approve a programme of ordinary meetings of the Board for the year; to ensure that Derby Homes meets deadlines in respect of its AGM and reporting to Derby City Council, and

- (n) consider any business set out in the notice convening the meeting.
- 4.3 In order to avoid a possible future tied vote for chair, the proposed new wording is (with track changes):
  - 1. FIRST MEETING

At the first meeting following each Annual General Meeting of Derby Homes, the Board shall

(a) elect a person to preside for the election or reaffirmation of the Chair

Should the Board be unable to agree on such a person the following precedence would be applied:

- 1 Longer continuous serving Vice Chair
- 2 Other Vice Chair
- 3 Chair of Governance
- 4 Chair of Audit
- 5 Longest continuous serving other Board Member

In all cases, this person needs to be someone not standing for election as Chair.

- (b) elect or reaffirm the Chair for the ensuing year
- (c) receive apologies
- (d) consider late items to be added to the agenda by the Chair
- (e) receive any declarations of interest from Board Members
- (f) elect the Vice Chairs for the ensuing year
- (g) approve the minutes of the last meeting

(h) receive any announcements from the Chair

(i) decide which committees, to establish for the next year

(j) decide the size and terms of reference for those committees

(k) appoint to those committees, and outside bodies except where appointment to those bodies has been delegated to the Managing Director

(I) agree a scheme of delegation or such part of it as it sees fit

(m) approve a programme of ordinary meetings of the Board for the year; to ensure that Derby Homes meets deadlines in respect of its AGM and reporting to Derby City Council, and

(n) consider any business set out in the notice convening the meeting.

## 5. OTHER OPTIONS CONSIDERED

5.1 To leave the Standing Orders unchanged – which would leave open the possibility of a future tied vote without a casting vote.
