External audit services

Further to our meeting yesterday, I am pleased to provide a summary of the issues we discussed and clarified in respect of our proposed external audit service for Derby Homes Limited ('the Company').

Corporation tax

As discussed, our fees for the calculation and audit of the corporation tax values included in the Company's accounts have already been incorporated within the £10,000 fee quoted. The following services have not however been included within the fee quoted:

- Preparation and filing of the corporation tax return
- Corporation tax advice.

Our proposed fee for the preparation and filing of the corporation tax return is £500.
