an update to the core values over the last few years too. These are shown in track changes in the relevant appendices.

4.4 The main proposed change relates to an increase in the amount above which a grant is deemed a major decision reserved to the Board which it is proposed to increase to £100,000 from £5,000. It has also been clarified that homelessness provision services are not included as many of these are delivered by third parties using the grant funding received from the Council. In all cases, grants and loans remain to be approved by the Council in addition.
