Report of Derby Homes Tenant Panel

1. **SUMMARY**

- 1.1 This report is to show the findings of the Tenant Panel's review of Local Offer 5, in addition to presenting recommendations.
- 1.2 Local Offer 5 - develop our own energy efficiency standards that will be above the government requirements. Full details can be found in appendix 1.

2. RECOMMENDATION

MATTER FOR CONSIDERATION 3.

The Tenant Panel were impressed with the work being carried out with regards to this Local Offer.

The work covers:

Current and future New Builds incorporating many innovations to provide energy efficient homes.

Solar panels.

Internal and external insulation, (CESP works).

Energy efficiency advice available to tenants.

WHAT WE DID

The panel had meetings with Kendal Hodder, Energy Efficiency Manager, Andy Higginbottom, Planned Maintenance Manager and Andy Palmer, Asset Manager to discuss what Derby Homes have already carried out to support this Local Offer and also to see what plans there are for the future.

The panel also consulted leaflets available to tenants, supplied by Derby Homes, to see if they are readily accessible and easy to understand.

The panel researched the Government standards and ongoing changes in energy efficiency to ensure Derby Homes complies with regulations.

Derby Homes have currently installed 1,000 Solar panels, 460 properties have had internal wall insulation fitted and 680 have had external wall insulation.
