1. **SUMMARY**

This report asks the Board to confirm the reappointment of Independent Board Member Mike Ainsley.

2. RECOMMENDATION

That the Board confirms the reappointment of Mike Ainsley as Independent Board Member from the 26 November 2015 until the AGM 2018

3. MATTER FOR CONSIDERATION

- 3.1 In accordance with Article 16(1) Mike Ainsley, Independent Board Member, is due to stand down at this AGM.
- 3.4 Article 16(3) states that if there are no other candidates to fill the post the retiring Board member shall, if willing to act, be deemed to have been reappointed unless a resolution not to reappoint the Board member is passed at the AGM.
- 3.5 Mike has confirmed he wishes to be reappointed to the Board.
- 3.6 The other 7 Board Members were contacted requesting that they advise us if they wished to pass a resolution not to re-appoint Mike at the AGM. Of these, 6 Board Members responded, fully supporting the proposal to reappoint Mike.
- 3.7 In accordance with Article 16(3), I propose Mike's reappointment to serve on the Board until the AGM in 2018.
- Details of retirement dates for Independent and Tenant Board Members is attached 3.8 at Appendix 1. Council Board Members are nominated annually by the Council.
