1. SUMMARY

- 3.1 The final accrual processing date for Derby Homes is 6 May 2011.
- 3.2 Costs or income of material relevance to Derby Homes will continue to be included in the year end accounts for 2010/11 until the annual audit has been completed and the accounts finalised.
- 3.3 The external audit by Pannell Kerr Foster commences on 6 June 2011.
- 3.4 The final audit clearance meeting is scheduled for 23 June 2011. The dates below are when year end accounts will be available to Audit Committee, Resources, Remuneration & Regeneration Committee and Board:
 - Draft final accounts and audit management letter will be presented to Audit Committee on 4 July 2011
 - Draft final accounts and audit management letter will be presented to Resources, Remuneration & Regeneration Committee on 7 July 2011. The minutes of the Audit Committee and any amendments to the accounts as a result will be presented verbally at the meeting.
 - Final audited accounts will be presented to the Board meeting on 28 July 2011 for approval.
 - Final accounts will be submitted to the Annual General Meeting (AGM) on 27 October 2011. The approved accounts will be presented at the AGM for acceptance by Derby City Council.
 - Accounts will be filed at Companies House by 16 December 2011.
