VIOLENCE AND AGGRESSION POLICY

Report of the Head of Housing Management

1. SUMMARY

1.1 This report explains that Derby Homes Violence and Aggression Policy has been reviewed and a revised policy is attached showing tracked changes.

2. RECOMMENDATION

2.1 That the Operational Board approves the revised Violence and Aggression Policy.

3. REASON FOR RECOMMENDATION

3.1 The existing Policy is very largely fit for purpose and only requires minor updating as explained in the report.

4. MATTER FOR CONSIDERATION

- 4.1 Derby Homes Violence and Aggression Policy was last reviewed in 26 April 2018. Therefore it is due for review under the policy for reviewing Derby Homes Key Policies.
- 4.2 A number of minor changes have been made to the document which are shown as tracked changes for ease of reference. The revised document is attached at appendix 1.
- 4.3 The revised policy has been amended to reflect the following:
 - The timescales for reviewing warning markers has been changed from six months to twelve months following advice from Derby Homes Information Governance Team.
 - A customer can now challenge a warning marker added to their tenancy by requesting a review by an independent Manager rather than through Derby Homes Complaints Policy.
 - A few other minor changes have been made to provide further clarity to the policy.

5. OTHER OPTIONS CONSIDERED

None. Derby Homes has a legal obligation under Health and Safety legislation to have such a Policy.
