CITY BOARD ELECTIONS 2011

Report of the Director & Company Secretary

1. SUMMARY

This report informs City Board Members of the arrangements for the conduct of City Board elections 2011.

2. RECOMMENDATION

3. MATTER FOR CONSIDERATION

3.1 In September 2009, the Derby Homes Board approved the process for the election of City Board Members. This year elections will be held in the South East area for four City Board Members. The City Board Members who currently represent this area will stand down at the Company's AGM in October.

3.2 The Board also agreed that Deputy positions will be phased out. The following Deputies will stand down in October, the positions will not be filled.

- 3.3 These City Board Members and Deputies will be able to stand in the election if they chose, subject to the eligibility rules*, along with any other candidates. They will need to complete the application forms, including obtaining a proposer and six seconders. However, they will not have to attend an interview but will be automatically selected to stand in the election.
 - * These are included in the information pack and includes provision that only **one** family member can be on the City Board.
- 3.4 Since last year's elections, two South West City Board Members have resigned. These two positions will also be included in the election.

- 3.5 We will encourage tenants to apply and publicise the elections through Derby Homes News, leaflets, Housing Focus Groups and posters in housing offices and the Resource Centre.
- 3.6 The timetable for the election process is attached at Appendix 1. City Board Members and Deputies standing down will be sent an application pack when it becomes available.
- 3.7 In addition to elections for City Board Members, we will also be holding elections for the Tenant main Board Members South East and South West. We welcome applications from City Board Members who represent these areas for main Board membership.
