1. SUMMARY

This report gives the outcome of the election for City Board Members for the North East, South West, South East and Leaseholders.

2. RECOMMENDATION

- 1. Peter Simpson has been elected unopposed as City Board Member North East for the period 29 November 2012 until the AGM in 2015
- Jolanta Szatkowska and Michael Waplington have been elected unopposed as South West City Board Members for the period 29 November 2012 until the AGM in 2013
- 3. Susan Boon has been elected unopposed as the South East City Board Member for the period 29 November 2012 until the AGM in 2014.
- 4. Winifred Buchan has been re-elected unopposed as Leaseholder City Board Member for the period 29 November 2012 until the AGM in 2015.

3. MATTER FOR CONSIDERATION

- 3.1 Nominations were sought for City Board Members North East, South West and South East and the Leaseholder City Board Member. An advert was placed in Derby Homes News and posters placed in Derby Homes' offices and the DACP Office. During the Summer, staff also attended various events around the City to promote the vacancies.
- 3.2 As a result, nominations were received from Peter Simpson for the North East position, Jolanta Szatkowska and Michael Waplington, for the South West, Susan Boon for the South East and Winifred Buchan for the Leaseholder position.
