1. SUMMARY

This report proposes the appointment of Board Members to Derby Homes Committees.

2. RECOMMENDATION

3. MATTER FOR CONSIDERATION

- 3.1 John Bloxsom has recently stood down as Chair of the Audit Committee. At its last meeting, the Committee agreed to recommend Tony Holme replaces John Bloxsom as Chair.
- 3.2 Tony Holme was appointed to Audit Committee in March this year and has already made a valuable contribution to the Committee's work. He has also successfully chaired some meetings in John's absence.
- 3.3 At the October meeting the Board appointed Paul Bayliss, Roy Webb and Bob Troup to the 3 Councillor Board Member places on the City Board. Since then, Roy Webb has stood and down and it is recommended that he is replaced by Mick Barker.
- 3.4 At the Chair's briefing on the 1 November, the constitution of the new City Board was discussed. It was agreed at the meeting that up to 5 Councillor Board members should be able to join the City Board if they wish. A report on the agenda recommends changes to the City Board's constitution including increasing the number of Councillor Board member places.
- 3.5 Margaret Redfern has indicated she would like to be appointed to the City Board.
