## **REVIEW OF NON-CORE ACTIVITIES**

Report of the Chief Executive

### 1. SUMMARY

On 30 September 2010, Derby Homes Board approved recommendations from the Executive Team to review non-core service activities over a three year period. The reviews being undertaken within the wider Business Transformation agenda approved by this Committee and the Board. This report details the service areas and planned dates for review reports to be completed.

#### 2. RECOMMENDATION

To note the content of this report and to consider whether there are other noncore activities to be added to the review.

#### 3. MATTER FOR CONSIDERATION

- 3.1 The Executive Team has identified a range of non-core activities where staff or contractors are employed and services are provided which are judged to be extra and value added, on top of the core management and maintenance service.
- 3.2 However, many of these services are very well valued by tenants and leaseholders.
- 3.3 The Executive Team recommends that individual reviews of each service should be undertaken over the next three years. In each case proposals arising from the reviews will be presented to the relevant Board and Committees of Derby Homes and progress overseen by the Value for Money group.
- 3.4 The table below shows the services identified and the schedule for the reviews.

#### 4. FINANCIAL AND BUSINESS PLAN IMPLICATIONS

A review of non-core activities is expected to achieve an estimated £100,000 cashable efficiencies by April 2015, against the baseline of 2010/11 Derby Homes Fee.
